

#### **TSCA First Ten Chemicals Product Examples**

#### Methodology

We found these examples of products containing the first 10 chemicals EPA will evaluate under the reformed Toxic Substances Control Act (TSCA). These were identified through two primary methods. First, we used Google to search for MSDS sheets listing the relevant chemicals—typically using the CAS number and limiting the search to PDF documents (e.g. using the search term "cas "81-33-4" filetype:pdf"). Second, we identified examples and product categories by searching EPA's CPCat: Chemical and Product Categories database, again typically using the CAS number.

## **Asbestos**

No new products were found that list asbestos as an ingredient; however, after-market brake pads likely to contain asbestos were relatively easy to find. A 2007 report by the California Air Resources Board also noted that it was easy to find aftermarket and older brake pads containing asbestos: https://www.arb.ca.gov/research/apr/past/01-333.pdf

Using the same product codes that the California report found as likely to contain asbestos, the brake pads pictured on this page were purchased at this website:

Note that the website does not note that the brake pads contain asbestos, but the box does include a warning label. The brake pads arrived in a cardboard "shoe box," loose and unwrapped essentially as pictured.
